**Setup Time: 9AM – 1PM**

**ALL booths must remain open until 10:00 P.M.**

**The Event will be open to the public at 2:00 P.M.**

**Vendors will be PROHIBITED without Special Event License on file at the chamber by Friday, August 11<sup>th</sup>.**

**ALL VENDOR FEES ARE NON-REFUNDABLE.**

Ice/water must be provided by the Vendor

Each exhibitor must make an application individually with one exhibitor per booth.

Notification of acceptance or rejection will be communicated to you as soon as possible.

**The Committee reserves the right to refuse any vendor.**

Vendors are responsible for all items needed in booth spaces and all must fit into the space provided including: **vehicles, trucks, trailers, hitches, tents, & tables.**

Please **list ALL food and non-food items you intend to sell.** Any food or non-food item that is not listed on your **application**, and approved by the Pell City Chamber of Commerce LMB&BBQ Bash Committee, may be rejected.

If you need **electrical hookups**, you must check the appropriate box on the application form. The Committee **MUST have this information and payment in advance.**

Volunteers will be available to help you to your spot. Volunteers will be wearing Green shirts & can be found in the park and around the Civic Center complex. Vehicles will be allowed in these areas only during set up times.

The Committee reserves the right to reject any material it deems unsuitable. No stink bombs, snakes, snap-n-pops, or silly string allowed. **All exhibitors are expected to comply with pertinent State of Alabama tax regulations.**

Advertising will begin prior to the show consisting of radio, television, newspaper, banners, & other means.

**Applications must be signed and filled out in its entirety where applicable. Please type or print clearly.**
